## **\*\* UNAPPROVED MINUTES \*\***

The regularly scheduled meeting of the Louisiana Area Assembly was held at the Alexandria Convention Center on Saturday, August 17, 2019, at 11:12 a.m., in Alexandria, LA. Tammy M., Chairperson, opened the meeting with a few moments of silence followed by the Serenity Prayer. She then read the Area 22 Assembly Mission Statement: The mission of the Louisiana AFG Area Assembly is to foster and support participation in service for Al-Anon and interest in the Steps, Traditions, and Concepts; to provide opportunities for groups to associate with other groups; to inform about the activities and service in our region; and to maintain representation to and from the World Service Conference (WSC).

Tammy asked all new Group Representatives (GRs) to stand to be welcomed by the Assembly. She then asked for volunteers to read Al-Anon's Twelve Traditions and Concepts of Service.

Tammy made pertinent announcements, including the dates of the 2020 Assembly weekends: January 18-19; April 4-5; August 15-16; and November 7-8.

Rachel B., Area Secretary, asked if all Group Representatives (GRs) received a copy of the unapproved minutes from Saturday, August 17, 2019. She asked for corrections; none were made. A motion to accept the minutes as amended was made by Heidi H., GR, and seconded by Amy B., GR.

## **OFFICER REPORTS**

### Treasurer's report: Eric N., Treasurer

Revenue for the third quarter was \$4,017. Expenses were \$3,725, leaving a net income of \$292. The beginning balance on July 1, 2019, was \$12,076, and the ending balance on September 30, 2019, was \$12,368. After subtracting the reserve of \$9,000, Alateen fundraiser funds of \$90, and South Central Regional Delegates Meeting (SCRDM) seed money of \$450 from the ending balance, the remaining cash on hand was \$2,828.

- ◆ Please ask your group treasurers to write the group's name and World Service Office (WSO) ID number on contribution checks. It's important to have both pieces of information.
- ◆ Most importantly, please ask your group treasurers to mail contributions to the correct Area treasurer. The Area treasurer's name and address will change on January 1, 2020. The correct name and address are always posted in the Members section of the state website.

Alternate Delegate's report: GW, Alternate Delegate—absent, no report

AA has requested that we keep a hotel night count again so they can be sure we are getting credit for the rooms we use. Also AA is entertaining bids for LA Area Assembly for 2021/2022. They will be voting on where to go or stay in January of 2020. Molly (AA Chair) will keep Alyson informed as things move forward.

- ◆ Knowledge-based Decision Making (KBDM) on Alateen: Drafting KBDM on Alateen: Strengthening Minimum Safety Requirements-WSO will not do this because of variances in laws per state. I have heard concerns which lead to controversy. Our preamble and 10<sup>th</sup> tradition guide us in this area "No Controversy". I listened to all voices, the minority and worldwide Al-Anon experience. My hope is to have this to present so it can be on the agenda for next Assembly. Our Area Assembly is responsible for ALL Alateen!
- ◆ Vision & Successes of LA Panel 57: We met as officers and as individuals to know each other personally to place Tradition Twelve principles above personalities. We did this multiple times to each identify a vision for our individual leadership roles. Previously officers' meetings were short, and rushed with no time for in depth discussions.
